Job Summary

Responsible for maintaining inmate security in Curry County Adult Detention Center including enforcement of rules, preventing escapes, inmate and detainee escort; operates under direct supervision. Position requires working under stress.

Minimum Qualifications

- Must be eighteen (18) years of age or older.
- High School diploma or GED certificate. Two (2) years applicable experience is desired but not required.
- One (1) year experience in detention work and supervision of inmates; knowledge of pertinent federal, state and county laws and policies. Education or experienced in interpersonal communications helpful but not required.
- Vision correctable to 20/20.
- Ability to successfully pass a background investigation. An academic exam may be administered.
- Able to write intelligible and complete reports and deal with situations requiring tact, understanding and good
 judgment; remain alert at all times and respond quickly in emergency situations; establish good working
 relationships with inmates and other staff members.
- Valid driver's license.
- A Detention Officer is an uncertified officer, with less than one (1) year of experience in detention work. Person
 must successfully pass forty (40) hours of accreditation course provided by Detention Center within the first year
 of employment.
- Must be able to understand, communicate, read and write in English.
- Bi-lingual is helpful, but not a requirement.
- Must successfully complete new hire physical and pre-employment drug screen.
- Ability to perform all essential duties as listed below.
- Ability to perform the essential duties in the working conditions described below.
- Ability to communicate effectively with large and small groups of people, and to diffuse stressful situations.
- Ability to travel, including traveling out of town and/or overnight.
- Computer literacy required, especially with knowledge of word processing, business-related and record keeping programs.
- Ability to perform essential duties and adapt to working conditions.
- No history of felony or misdemeanor convictions involving moral turpitude, violence, illegal drug distribution or dishonesty.

	Plans and performs a wide range of detention duties to ensure the proper booking and incarceration
	and safety of persons committed to the Detention Center.
	Works from training education, instructions, directions of supervisor, and overall policy to receive and
	detain incarcerated persons.
	Processes incoming inmates and detainees by completing booking sheets, pat and strip search, personal history, medical screening, and other essential duties to the proper care and incarceration of the inmates and detainees.
	Performs fingerprinting and photographing of inmates.
	Inspects pods, day rooms, jail cells, recreation area, and classroom to insure cleanliness and orderliness. Record any pertinent conditions during periodic patrols of pods, recreation area and cells.
	Sees that inmates and detainees receive showers and clothing and responds to additional personal needs in accordance with policies.
	Periodically works in control room to keep constant watch on all sections of the Detention Center via TV cameras. Control all doors and entrances. Forward telephone calls to the appropriate parties. In event of emergency, contact appropriate personnel.
	May transfer inmates and detainees to court and other appearances. Serves as escort for visiting lawyers and others. Escort's inmates and detainees to various sections of the detention center, including kitchen or recreation room.
	Coordinates and cooperates with other law enforcement agencies and judiciary agencies as necessary.
	Assists in processing various bills and documents and assists in bonding. Records all monies and personal items for storage.
	Appropriately distributes medications prescribed by doctors to inmates and detainees, complete appropriate documentation and enters information into computer.
	Obtains required signature from inmates and detainees for personal and accountable items.
	Deals with verbal and physical abuse from inmates. Adult Detention Center may house up to 200 inmates.
	Search inmates and detainees as well as their cells and restrain inmates when necessary.
	Employee must perform all duties with minimal supervision. Employee may be required to work irregular hours, attend job related meetings, and perform other duties as assigned.
	May be required to transport inmates and detainees to other facilities.
	At the Adult Detention Center, we have two (2) shifts and you will be assigned to one of the shifts,
	you may be assigned to a different shift with a seventy-two (72) hour notice. This does not apply
	when we ask you to work overtime. Shifts may be changed to three (3) and you will be assigned to
	one of the three (3) shifts.
	Must comply with the County Personnel Policy, and other Policies as approved by the Board of Commission.
	Follow the State of New Mexico Purchasing and Procurement laws, County Purchasing Policy and grant agreements in making purchases, transferring and depositing of assets.

Description of Duties:

Employee is responsible for enforcement of rules & regulations in detention facility, preventing escapes & riots, maintaining order & discipline among inmate, escorting inmates to and from cells and work assignments. Also responsible for operating and inspecting various security devices, reporting violations of rules & keeping count of inmates as assigned. Duties include controlling inmates from work stations or by patrolling cell blocks, dormitories, corridors and work areas; inspecting all areas of facility for unauthorized objects; checking sanitary conditions and fire and safety hazards; enforcing rules of conduct, security and labor standards by making written and verbal reports of significant violations or irregularities to supervisors. Employee must assist in supervision of inmates being transferred to other facilities or appearing in court; distributing cleaning and sanitation supplies as well as pick-up and delivery personal laundry and bedding; delivers mail and distributes medication as needed within policy guidelines. Employee must operate electric cell doors; control visitation of relatives, attorneys and others. Employee is expected to be familiar with federal, state and county and departmental laws and policies pertinent to the position, departmental directives, detention officer's report manual, techniques and precautionary measures to be used in escort and supervision of inmates and typical behavior pattern of inmates; skill in use of camera and fingerprinting. Employee is expected to know and understand County Personnel Policies and perform any related work as required. Employee must be aware that position may involve life-
